Next Meeting March 11th

Please join SSSNA for the next meeting on Tuesday, March 11th at 7:00pm at the St. Paul of the Cross Retreat Center. We will have a working meeting and need to have YOUR input. It is critical to have as many people there as possible. Klavon Design Associates, Inc. will be at the meeting to gather ideas from Slopes neighbors about the 18th Street corridor. You can read more about the Elm Street initiative in the committee report. The idea is to brainstorm ideas of how we want the 'look' of the streetscape throughout the Slopes. This will be a all of template for the Slopes improvements so that there will be a thoughtful plan that is consistent. The follow up for the results of this meeting will be at our April 1st meeting.

We will also have a group if Duquesne University students at the meeting to inform us of their doing a Service Learning Project in South Side Park. As you know, South Side Park is a 64 acre park bordered by 18th Street in the South Side Slopes. The class project scope will include clean up as well as signage for the currently unmarked trail heads and along the trails. They intend to walk throughout the park on April 19th and are seeking volunteers. It is exciting to know that our issues are recognized at the University level and will be addressed.

<u>Duquesne University</u> <u>partners with Graffiti Watch</u> <u>to Identify Graffiti</u>

DETAILS: On Saturday, March 8th, Duquesne University in collaboration with the South Side Graffiti Watch group will take to the streets of the South Side identifying graffitied properties. students volunteering are a part of Keep It Clean South Side, an adopt-a-block created by Duquesne University and the Pennsylvania Resources Council (PRC). "The goal of this Saturday's event is to locate as many graffitied properties in the South Side as we can," said Sarah Alessio, Program Specialist at PRC and member of the Graffiti Watch group. "We will use this information to help us target locations for graffiti removal during the Spring Cleanup which will take place on April 19th." The students will not only be identifying graffitied locations, but will also be distributing educational information to the owners of these graffitied properties. The information will include Graffiti Busters removal forms and a "how to" guide for residents to help them report and remove graffiti on their property.

The Graffiti Watch group aims at working with community members to achieve the goal of removing and preventing graffiti on the South Side. Members of the graffiti watch committee include: City Councilman Bruce Kraus, representatives from the South Side Slopes Neighborhood Association, the South Side Community Council, the Pennsylvania Resources Council, board members from the South Side Local Development Company and the Brashear Association and community members from both the South Side Flats and

Slopes. To date the group has organized one paint out event, distributed hundred's of educational flyers, and are working with the City of Pittsburgh's graffiti busters on a coordinated effort to get graffiti removed from masonry walls and structures.

What you missed 2/12!

Our SSSNA Board President, Brad Palmisiano, introduced the elected officials present which were Bruce Kraus, City Councilman District 3, and Eugene Ricciardi, District Justice for our area. Also present was Neil Parham, representative of the Mayor's Office.

Brad introduced Ms. Tiffani Emig from the Rivers of Steel National Heritage Area out of Homestead. Ms. Tiffani explained the purpose of Rivers of Steel National Heritage Area - to gather and preserve the heritage of our great city...its stories, its sights, its struggles and its successes over the years. includes stories of our immigrants and organizations. ethnic This accomplished by Pittsburgh's people telling their stories on tape and on film, sending in pictures of neighborhoods, past and present. The Rivers of Steel National Heritage Area will then sponsor exhibits, a catalogue, pod casts and curriculums for our schools, along with Archive... so that our heritage is not lost in the fog of the past.

Brad Palmisiano then asked Committee Reports of Board members present. Joe Ciccola reported Beautification Committee is getting ready for our Spring plantings. Fr. Don Ware reported that Elm Street is proceeding with several projects, including engineering study of our Steps, further work on our gateway Brosville Monastery Avenue garden, and ongoing work on the South 18th Street gateway corridor. Brad reported on the progress of the development planned for 13th Street & Street Janice Sarah Serra. our representative at the South Side Planning Forum, alerted us to the ongoing update of the South Side Neighborhood Plan. Brad then announced that Claudia Hart, SSSNA Board member, is moving out of the city soon. We want to thank Claudia for her time and effort as part of our neighborhood Board. The Board will replace her according to our by-laws.

Our Councilman Bruce Kraus then held an informal and informative discussion regarding topics of interest to our neighborhood. These topics included:

- The Development taking place on 13th and Sarah Streets and the issues surrounding it.
- ➤ The SS Planning Forum process for developers planning construction in the South Side.
- ➤ Bruce's office will be notified of any development plans for the South Side and will alert the appropriate South Side entities.
- ➤ Concerns over Allentown and its challenges with which he is helping them especially public safety issues.
- ➤ Bruce's ongoing concern with vandalism, graffiti and litter in our community.
- ➤ Landlord responsibility legislation.
- ➤ Ongoing concern with parking on the South Side, and possible solutions.

<u>Committee Reports:</u> Elm Street Committee

South 18th Streetscape Design RFP

- Judy reported that proposals had been received from Pashek. Perkins Eastman, and Klavon. Interviews were conducted with Pashek and Klavon on February 7th. It was decided not to interview Perkins Eastman because their proposed budget was twice as high as the other two submissions. Peter, Bev, John served on the interview committee and were staffed by Judy. Josette Fitzgibbons was present for the Pashek interview. All proposals received also were

forwarded to entire committee for review. Following lengthy discussion of the two proposals, the contract was awarded to Klavon.

Public Staircase Inspection RFP -

Judy reported that proposals were received from Wilbur Smith and Michael Baker. Interviews were conducted on Monday, February 11. Peter, John and Kevin Hanley served on the interview committee and were staffed by Judy. Josette Fitzgibbons and Ryszard Janik (Department of City Planning) were also present for the interviews. The proposals were also forwarded to entire committee for review. Following discussion of the two proposals, the contract was awarded to Michael Baker.

Neville Ice Arena - Judy reported that South Side LDC will be forwarding a draft License Agreement and a draft RFP to the City for their review and approval. The License Agreement will give South Side LDC the right of access to the property to conduct an existing conditions analysis of the facility. The RFP will be sent to firms capable of conducting such an analysis. The goal was to have both sent to the City by the end of the week of February 18.

Good Neighbor Booklet - Judy reported that changes recommended by the ES committee are being incorporated into the text. South Side LDC intern Zack has been charged with translating City lighting standards into understandable language, which is proving to be more difficult than anticipated. SSLDC Marketing Manager Jen will be responsible for layout and graphics to prepare the booklet for publication.

Monastery/Brosville Gateway Garden Signage - Peter reported on progress of design and potential lighting options. Following discussion it was decided to put fabrication out to bid.

Additional neighborhood signage - Peter presented an idea that would incorporate elements of the Brosville sculpture design, using hillside housing images, to create pillar like sculptures to be placed at various key locations. Following discussion, Peter was asked to further flesh out the concept.

Welcome to Neighborhood Basket - Judy reminded committee that this project is a funding deliverable. Image and Identity committee members Misi and Dawn will set up a meeting to discuss project in the near future.

South Side Park **Duquesne** University Project - Judy reported that South Side resident and former South Side LDC Board member Evan Stoddard, had contacted her regarding a potential project for his graduate seminar class at Duquesne University. Evan was given a disk containing the South Side Park Master Plan which he shared with his students. Since then, several ES Committee members, and others have been receiving calls from a variety of students regarding their ideas for a class project. Following discussion, it was decided that one point person from the neighborhood should work with the students to make sure project conformed to park master upcoming plan and Elm Street projects. SSSNA is celebrating its 10th year this There have been hundreds of fall. thousands of volunteer hours spent in the Slopes to make our neighborhood clean, safe and green! Thank you to the hundreds of people who have helped over the years. What is exciting and most of you may not know is that those volunteer hours translate in to dollars. For every volunteer hour spent in the community, it is estimated at a value of more that \$17 per hour. Not in "real" money, but when non-profit groups seek grant funding, these hours translate in to a virtual dollar amount. Did you know that SSSNA volunteers worked approximately 11,987 hours in 2007? We believe that we did not account for every hour. For 2008 we have a better tracking system. We need to hear from you. If you spend time picking up trash, cleaning graffiti, weeding the community gardens, please let us know. Those hours count. The structured events and meetings are documented (that is why we have you sign in), but individual efforts for Slopes improvements are not captured. We need every minute to count. What we need to know is the activity, when, how long, and how many people. For example: John Smith and his 2 daughters spent 1.5 hours picking up trash along Josephine Street.
