### What you missed 10/9!

Thirty neighbors met for our monthly SSSNA meeting in St. Paul of the Cross Retreat Center Main Lounge. Board President Brad Palmisiano welcomed State Representative Harry Readshaw to the meeting. Brad then updated a number of items of interest:

- ➤ The Zoning Board hearing regarding Angel's Night Club on Josephine St. will be at 9:00 AM on Thursday, October 18<sup>th</sup> at 200 Ross Street. Neighbors are invited to express their concerns.
- Clean-up for Step Trek will continue at 9:00 AM on Saturday, October 13<sup>th</sup>. Volunteers will meet at 21<sup>st</sup> and Josephine Street.
- ➤ DeAnn Berry is spearheading the Monongahela Playground reconstruction efforts, with the full backing of SSSNA.
- > Projects the SSSNA has been involved in during 2007 include a completion of safety lighting on the 10<sup>th</sup> St. footbridge, the designation of SSSNA as a 501 3c charitable organization, general cleanup efforts around the Slopes neighborhood, and Step Trek along with Elm Street these projects.
- ➤ Projects for the year 2008 include Grants for safety lighting on the Mission Street steps from Mission Street to South Side Park, a

Sidewalk Grant for repair work at 25<sup>th</sup> and Josephine Streets, general clean up of Slopes neighborhood, and Elm Street projects.

The meeting next moved to Election of five Board members for 2 year terms. Kate Fink has finished her term and is not running. We thank Kate for her years of service on the Board. The five Board members elected unanimously were: Joe Ciccola, Matt Schaefer, Janice Serra, Fr. Donald Ware, and Peter Kreuthmeier (a new Board member).

Fr. Don Ware, Chairperson of Elm Street Committee, gave a brief update on Elm Street work. This includes renovation of the Pius Street All Wars Memorial, construction of the gateway garden at Brosville and Monastery Streets, a Grant for three garbage & recyclable cans at strategic spots in the Slopes, Community Attitude Survey, a potential recycling area along Brosville Street, an engineering study of the South Side Park ice arena, and continued work on the 18<sup>th</sup> and Josephine St. garden, including an engineering study of the steps at the gateway garden on S 18<sup>th</sup> St., determining the cost of repairing the steps.

Janice Serra told the audience about the Forum meeting she had just come from. One major topic of discussion was the proposal by Matcon Diamond to build an Office Bldg on Carson near 29<sup>th</sup> Street. This development will no longer seek to close 29<sup>th</sup> St. However, other concerns are still to be addressed: the integrity of the design which should fit into the neighborhood, and parking. SSLDC is following up on these issues.

Bev Boggio gave an update on the Step Trek to take place on October 14<sup>th</sup>. She noted some of the sponsors, the brochure which will be given out, the

musical program at the sign-in on at the UPMC South Side parking lot on  $21^{st}$  & Josephine Streets, and Cynthia Cooley's art that is an integral part of the Step Trek, featured on the tee shirts.

Johno Prascak has offered a print of "The Chief" to be raffled and his studio is on the Gold Route. The Meeting was adjourned by 7:50 PM. *By Fr. Don Ware, C.P.*

In an election held at the October general meeting, Slopes resident and architect Peter Kreuthmeier was elected as the newest board member of the SSSNA.

"As an architect and a citizen of the neighborhood, my interest in the South Side Slopes is both personal and public," said Peter. "Personal because I live here, and public because I am happy to share my passion for the built environment."

A successful architect and principal at Loysen + Kreuthmeier Architects, an award-winning Pittsburgh-based with a focus on design and technical quality, Peter brings a collaborative view how meaningful of create to improvements in the Slopes neighborhood. He currently serves on the Elm Street Committee, offering his extensive background in design and construction to help guide the building of the recently dedicated Brosville garden at the intersection with Monastery St.



We are still collecting data for the numbers. We had approximately 300 register online through Active.com. This was our first year with online registration and that is a good number. We learned a great deal in the process. Once again, the tee shirt art was wonderful and captured the beauty of our neighborhood! We are so lucky to have such talented artists to memorialize the Slopes. We were lucky to have Author Bob Regan, who partnered with us for the very first StepTrek in 2000, join us to sign his book "The Steps of Pittsburgh, Portrait of a City". ## Beautification Committee

### Elm Street Committee

neighborhood clean-up and one week prior to the Step Trek. Ceremony will be kept simple. Refreshments will be served. Vento is aware of the event and according to Klavon is working to make sure all aspects of his work are complete.

South 18th Street Steps – Judy reported that in conversation with the URA and with DPW, it was suggested that ES funds be used to hire an engineering firm to determine the exact condition of the steps and to obtain a realistic estimate for the cost of repairs. Following discussion, it was decided to pursue hiring an engineering firm to do a formal evaluation of the South 18th Street steps.

**Pius Street Monument** – Ornamental fencing has been installed, but needs to be painted. Judy reported that Duquesne Light Company has a program that may provide the funding to light the flagpole. Following discussion, it was decided to hire a painter to paint both the ornamental fence and the flagpole, and to apply to Duquesne Light Company assistance in lighting the flagpole. Proposed change in meeting day and time: Due to changes in some committee members' schedules, it was decided to move the November ES Committee meeting to coincide with the date of the SSSNA Board meeting on November 20th.

Budget Revision - Judy reported that she and South Side LDC Executive

Director Rick Belloli had met with the URA about the proposed revision. The URA will be amending all ES contracts to reflect cost categories used by the State. These are very broadly defined and will allow us to move forward with projects without having to continually amend the contract. Contract revision will also include an additional \$20,000 of funds that can be used for marketing activities. A meeting with the Image and Identity/Outreach committee will be scheduled to discuss marketing strategies.

**Demonstration Grants** Judy reported reimbursement checks had been received from PDC for the trash cans, the Real Estate Academy, and the Urban Tree Tending seminar. Funds for the Gateway Signage project revert to the State in June of 2008. Committee agreed to be aggressive in moving signage project forward.

**Opportunities: Additional Grant** Judy reported that applications for a Community Connections Grant (for historic photographic signage) and a PPND Mini-Grant (for organizational capacity) have been submitted. Notification should occur at the end of October.

**Community Attitude Survey**: Committee agreed to continue efforts to generate 10% response rate to PDC survey. Bev reported that 200 copies were mailed with the October SSSNA newsletter. Father Don reported that he intends to pass them out following services. Surveys will also be provided at Brosville Ribbon cutting, SSSNA general meeting, and at Step Trek.

Potential Recycling Project: Judy reported that she will be meeting with Ben Carlise at the Brosville lot to discuss the potential for development of the site as a recycling drop off location. She will also be taking a list of other DPW related tasks/requests including the location of the new combination trash/recyclable cans and possibility the of streetscape improvements at the South 18th Street Pius/Mission Streets intersection which John reminded Committee members had been part of last month's discussions. Committee recommends that existing trash cans be relocated to other areas in the Slopes and be removed completely from the neighborhood.

New Playground: Brad brought the discussion of a new playground for the neighborhood to the attention of the Committee. Since the proposed location is not in the Elm Street district. ES funds cannot be used for its construction. However, Committee discussed supporting the proposal and working with DPW to use ES funds for a DPW project in the ES district in order to free potential funds for use towards the playground. Judy will add this to her list for discussion with Ben Carlise.

# SSSNA Works on 2008 Budget

Each autumn, the separate committees of the SSSNA put together their budget projections for the coming fiscal year. Whether it's Beautification, Outreach or any of the other standing committees, the budget takes into consideration expected programs and initiatives that may be executed over the coming 12 months. In addition, the prior year's expenses generally serve as a guide to help plan for the coming year. The chairpersons submit these initiatives and an estimate of their costs as part of their overall plan for the committee.

The SSSNA executive committee reviews all budgets. Questions may be asked to help in understanding the plans and needs of the individual committee. In the process, there may be tweaks to the submitted budgets before an overall budget is put before the board for a final vote. The process is meant to capture the

goals of the committees, while keeping costs under control.

SSSNA is diligent with expenses and operates within the revenue projections of each year. The main source of income is the annual StepTrek. Some of the larger fixed expenses include the newsletter and board insurance. The cost of mailing had always been another large expense, but since SSSNA became a 501 (C) 3 organization, the cost of mailing dropped by approximately 60% due to the discount afforded non-profit organizations.
